Acceptance of Quotation and Terms and Conditions

- Quotations are valid for a period of 7 days.
- The placement of an order for design and/or any other services offered by JR
 Development, constitutes acceptance of the estimate or quotation and agreement to
 comply fully with all the Terms and Conditions and forms a Contract for Business
 between the client and JR Development.

Design Fees & Payment

- Fees for design services to be provided by JR Development, will be set out in the written estimate or quotation that is provided to the client.
- At the time of the client's acceptance of this estimate or quotation, indicating acceptance of the Terms & Conditions, a non-refundable deposit of 50% of the quoted fee will become immediately due.
- Work on the project will not commence until JR Development has received the 50% deposit.
